# **PANNIG FOR THE PEOPL** Our ambition: Put the people back at the top of planners' priorities

#### **BEACHES FOR RECREATION & TOURISM**

The golden rule has been upheld: Israel's public beaches will remain preserved for recreation and tourism. Our legal and planning expertise minimized the damage of a controversial law which aims to 'boost' tourism at the expense of beach-goers' open access to the coast. As an incentive to entrepreneurs to build more hotels, the law allows for 20% of new hotels to be sold as private residences. Our advocacy, coupled with strong public protest, ensured that the law will not apply to beachfront hotels. This is a significant achievement because Israel's limited shore (122 miles long) doesn't have room to accommodate private beach residences.

Israel's most pressing social, economic and environmental challenge remains the country's rapidly growing housing needs. The government is pushing for speedy housing solutions. But planners fail to see the people as they introduce a series of shortcuts, loopholes and fast-track committees. *These quick-fix reforms raise serious* environmental, health and social concerns for future homeowners. Addressing the public's need for pocket parks, heritage sites, open spaces and transportation strengthens our cities and improves Israelis' quality of life.

#### **CLEAN-UP FOR NEW HOMES**

Plans to build 3.000 new homes on severely contaminated land in Herzliya, a former Israel Military Industries (IMI) site, are being accelerated despite our 2015 High Court victory mandating full remediation before housing begins.

The site is contaminated with toxins and carcinogens from the manufacture of military hardware and the findings of environmental risk surveys could affect the location of key elements of the new neighborhood such as schools and parks. The Herzliya housing plans, which are being rushed through a special fast-track committee, also fail to provide transport solutions for the new neighborhood. Such a planning failure will affect the quality of life of current and future residents. Together with local activists, we have turned to the Tel Aviv District Court to halt the planning process until environmental risk surveys and remediation have been completed.

#### **OPEN SPACES FOR QUALITY OF LIFE**

Israel's population has grown tenfold since the founding of the State. In the rush to meet housing needs, planning authorities are replacing existing zoning plans with a consolidated version which drastically reduces environmental protections and will irreversibly reshape Israel's landscape. As a result, 50,000 acres of currently protected green lungs and beaches will be built over. Using our special legal standing, we turned to the High Court of Justice to stop the approval of the new plan due to conflicts of interest, planning violations and lack of due process.







"Former holding tanks for hazardous chemicals are buried in the fields where the new neighborhood is planned to be built. You can easily notice hot spots where the chemicals are seeping to the surface. How can homes and schools be built here without proper clean-up? #### TRANSPORT FOR CONNECTED COMMUNTIES

As one of the most densely populated countries in the world, Israel is ideally suited to support a robust public transit system. In reality, Israel's roads are gridlocked and the use of public transport has plummeted from 64% in the '70s to 24% today. Vigorous public transport solutions are needed to encourage Israelis to travel by public transportation instead of private cars. Yet planners are ignoring transportation needs and are removing prerequisites for basic infrastructure as they advance hundreds of new neighborhoods. We are promoting a bill which will require planners to integrate public transport solutions when planning new communities, including pedestrian and bike paths.



# STRENGTHENING GIVE SOCIETY Our ambition: Empower Israelis to participate in decisions affecting their environment, health and quality of life

#### **CIVIL SOCIETY PROTECTS PUBLIC INTERESTS**

The government's proposed deal for quickly extracting offshore natural gas propelled Israelis to the streets in a call to defend their social, economic and environmental rights. In a historic ruling, the High Court of Justice suspended the contentious deal due to an illegal stability clause, which was the heart of our petition. The clause would have prevented future laws regulating offshore environmental protection, such as our pending Marine Management Bill.

The Court accepted in full our petition, submitted together with other organizations from Israel's civil society, and ensured that protecting Israel's marine environment remains a top priority. The Court sent a strong message to decision makers: Civil society has the power to protect the interests of the Israeli public.

#### **ENVIRONMENTAL DISASTER LEADS TO GREATER TRANSPARENCY**



"What was not transparent must be made transparent," ruled the Deputy-President of the High Court of Justice in response to our petition to remove an outdated status of secrecy surrounding the Eilat-Ashkelon Pipeline Company (EAPC) after the company caused a major crude oil spill (5,000 cubic meters) in the southern desert. For decades an anachronistic confidentiality order, dating back to 1968 when EAPC had financial and diplomatic ties with Iran, has shielded the company from government and public scrutiny. Although times have changed, EAPC is still immune from environmental standards and planning and building laws. Our petition has led to heightened transparency surrounding all environmental and planning aspects of EAPC's operations - activities which directly affect the public's health and environment.

Democracy is more than just voting. It's about everyday life; it's about standing up for your rights and taking actions to improve environmental conditions. As a Western democracy, Israel must uphold the environmental rights of all Israelis with the same vigor as other human rights.

#### **25 YEARS OF ENVIRONMENTAL PROTECTION**

In a festive fundraising event, more than 500 supporters donors, philanthropic partners, founders, past and present ministers and members of Knesset, leading figures in the business sector, community partners, generations of Adam Teva V'Din staff and honored guests, joined us to celebrate our 25th anniversary. President Rivlin wished us well in a warm video greeting, emphasizing the leading role we have in protecting Israel's environment for future generations. The finale was a show-stopping performance by Shalom Hanoch - an Israeli cultural icon. We were deeply moved by the show of love and goodwill from our friends and supporters.



#### SECOND GENERATION SUSTAINS ENVIRONMENTAL ACTIVISM

# **PROMOTING HEALTHER COMMUNITES** Our ambition: Hold the government and polluters accountable for cleaner and safer air, water an food and give families the tools to protect their health and quality of life



#### **CLEAN AIR FOR HAIFA**

Plans to expand Haifa's worst industrial polluter, Israel Oil Refineries ("Bazan"), have been suspended. Haifa, Israel's third largest city and home to a mixed population of 500,000 people, has been recognized as the country's pollution hotspot for decades. Sick of breathing in toxic cocktails of filthy air, Israelis are standing up for Haifa's right to clean air. The threat of our pending legal action and intensified public protests convinced the National Planning & Building Council to convene an extraordinary meeting. In an unprecedented decision,

plans to expand Bazan's petrochemical complex were suspended pending further review, giving vulnerable communities in Haifa hope for a new era of environmental protection.

work and play. Environmental protection is not a luxury - it is a matter of survival. Strong environmental protections are the building blocks for healthy, safe and vibrant communities. It is the super glue which makes Israel the place we know and love.

#### **SAFER POLICIES, SAFER FAMILIES**

Israel's environment is where we live.

We have developed new working relationships with the Ministry of Health & Ministry of Agriculture to build trust as we propose changes and new approaches to environmental health. Our revised private member's bill, "Reducing the Risks of Pesticide Use", accelerated official review and amendment of pesticide policies and frameworks. Thanks to direct advocacy before the Ministry of Health, we leveraged improved standards in glass, ceramic and children's food contact utensils. Our next step will be to prepare new legislation to create a kid-friendly, chemical-free environment for Israeli families in line with U.S. and European models.

#### **EQUAL RIGHTS FOR EQUAL CITIZENS**

The neighborhood of Shuafat, in East Jerusalem, has suffered from prolonged neglect. Despite the separation fence which surrounds the neighborhood, Shuafat is under the jurisdiction of the Jerusalem Municipality. However, residents don't receive basic services provided to all Jerusalemites - a situation which heightens preexisting tensions and unrest. Garbage collection has been outsourced, resulting in haphazard waste collection and lack of oversight. Piles of uncollected trash are either burned or residents are forced to pay for collection at their own expense. This is a severe sanitation hazard and direct damage to the residents' quality of life. When the Municipality repeatedly ignored the residents' concerns, our solid waste experts stepped in. We proved numerous failings and miscalculations in the City tender, including limited services which met the needs of only a third of the neighborhood's residents.

Thanks to our intervention, representatives from Shuafat, Adam Teva V'Din and the City are devising a new waste collection plan, including oversight mechanisms and public participation.



Israeli parents are hungry for credible information to make informed decisions and secure healthy homes for their children. Over 7,500 Israelis joined our special interest group of advocates who want to see better oversight on environmental health issues. Our public awareness campaign "Not on My Plate" advocating for chemical-free plastic products and other food-related utensils, offered parents practical, consumer-friendly tips. Our "Double Standards" Report, highlighting the differences in standards applied to the production and oversight of food for the Israeli market compared to those produced for export to Europe and beyond, sparked a vigorous online debate on social media channels.

# CARING FOR FUTURE GENERATION Our ambition: Manage and conserve Israel's resources for future generation

#### **PROTECTING THE MEDITERRANEAN**

The Mediterranean is a vital component in Israel's economy, defense, tourism and transportation sectors. However Israel has no regulative framework to manage and protect this essential resource. Our Marine Management bill, based on eco-system based approaches, aims to fill this legislative void by establishing a Marine Management Authority. The pending bill is being led by the heads of three prominent Knesset Committees: Interior & Environment Committee, Finance Committee and Economics Committee. Their valuable endorsement is key as the bill moves forward in the Knesset. We are also engaged in an ongoing dialogue with business stakeholders who will mutually benefit from a Marine



Authority, including the largest natural gas corporation, Noble Energy. Together we are identifying opportunities and obstacles in order to ensure the most effective framework to protect the Mediterranean and put Israel in line with the marine environmental standards of our European neighbors.

#### **KEEPING THE DEAD SEA ALIVE**

The Dead Sea is drying up at an alarming rate. The relentless degradation is not as a result of climate change or drought, but rather due to decades of government neglect and mismanagement. The Dead Sea Works, a mineral mining company, is pumping unrestricted amounts of water without water extraction permits or government supervision.

Our legal and scientific team has turned to the special Water Tribunal to limit the amount of water extracted from the Dead Sea and improve oversight in order to correct the imbalance of water extracted vs. water replenished.

determines how our children will experience it tomorrow. An environmentally-sound economy promotes cleaner and more efficient industries, more jobs, innovative technologies and brings Israel in line with accepted standards of the Western World. However, environmental considerations are often sidelined, leading to irreversible consequences for the national landscape, natural resources, public health and quality of life.

In order to put Israel on the path to a sustainable future, stakeholders from the public, business and government sectors must couple economic growth with environmental security.

#### **CHANGING THE ENERGY PARADIGM**

The energy economy has been sidetracked from expanding solar energy and energy efficiency by the prospect of a decade of offshore natural gas. We are leading change by developing tools to help Israel meet targets for a diversified energy economy. One legislative bill we drafted will boost non-commercial rooftop solar energy by offering tax relief to householders providing power to the national grid. In the High Court of Justice, our petition spurred the government to integrate energy efficiency measures within the national greenhouse gas reduction plan, to be published at the end of 2016. And we are developing a model 'negawatts' policy that places a value on energy not used to encourage businesses and institutions to save power.



\$260 million (1 billion NIS), collected from various environment-related fees and fines, are earmarked for strengthening Israel's burgeoning recycling sector. These designated funds, from the Maintenance of Cleanliness Fund, play a vital role in financing local authorities' waste-separating activities. However, the government recently attempted to divert the recycling funds to the general budget in a move which would have halted Israel's ten year investment in recycling. Thanks to our advocacy and pressure, the plan was cancelled - safeguarding funds which are essential to the future of Israel's recycling economy.
