Adam Teva V'Din: a skilled and dedicated team, a robust professional toolbox, and a bold advocacy agenda

Litigation - Adam Teva V'Din sues powerful business enterprises that cause environmental damage and files courtroom actions when the government fails to enforce environmental laws and standards. With special standing under law to represent the public in legal cases, our litigation has secured precedents on industrial pollution, river rehabilitation, auto fuel standards, remediation of contaminated sites, and coastline protection. and protected the rights of free access of all Israelis to public beaches and municipal parks.

Legislation - Adam Teva V'Din initiates, drafts, and campaigns for environmental bills in order to catalyze parliamentary adoption of environmental laws. Most of Israel's environmental laws of the last two decades were initiated and drafted by Adam Teva V'Din, including the Beverage Container Deposit Law (1999), Coastline Protection Law (2004), Clean Air Act (2008), and the Packaging Waste Recycling Law (2011).

Planning - Adam Teva V'Din represents environmental organizations on key planning boards, including those which determine pivotal land use strategies. like the national master plan for the coastline. The National Planning & Construction Law names Adam Teva V'Din as one of four non-government agencies authorized to represent the public in planning interventions at local, district and national levels.

Science - Adam Teva V'Din's environmental scientists guarantee a solid scientific foundation to our advocacy; our in-house team provide Expert Opinions supporting our positions in the courts, in the Knesset, and before planning boards.

Policy & Strategy - Adam Teva V'Din's core advocacy programs are integrated across the board for maximum effect. Government plans, budgets and regulatory programs are monitored to ensure a strong public-interest response when, for example, officials attempt to weaken or even roll-back environmental protection frameworks.

Communications - Adam Teva V'Din's communications program informs, educates, and alerts the widest possible audience to the environmental dilemmas of the day. The press now recognizes 'the environment' as a vital, relevant current issue, and our social media program has recruited tens of thousands of Israelis as online environmental activists.

UNDER PRESSURE: In 2019, after a year of political paralysis, the lived-in environment is deteriorating. Adam Teva V'Din is prioritizing these issues for the next government's urgent attention.

Clean air, energy & climate change - government agencies have not curbed industrial air pollution in Haifa Bay (according to the State Comptroller). The Energy Ministry is preoccupied by the new offshore gas industry at the expense of reforms to the national grid necessary to build a sustainable energy economy. Israel has paid lip service to climate change by setting (low) targets, but without adopting a coherent national strategy or legislative framework to promote climate resilience.

Coastline protection - public beaches are disappearing under new development that is reshaping the Mediterranean coastline and damaging the marine environment.

Public transport - Israel has built miles of highways but under-invested in public transport. With no viable alternative, people spend hours daily in traffic jams. New neighborhoods are going up with no provision for public transport.

Natural resources - use of water in the commercial minerals industry is shrinking the Dead Sea by 4 feet every year, without intervention by the Water Authority. Israel is dependent on water produced by vulnerable and energy-guzzling desalination industries because hundreds of water wells are closed due to contamination.

Pesticides reduction - the government ignores the typical Israeli 'salad' diet when setting pesticide exposure levels. Chemicals banned in Europe are used daily in Israeli agriculture, and Israeli kids are exposed to pesticides at every meal.

Solid waste management - despite regulatory frameworks for recycling of bottles, plastic bags, and packaging waste, Israel is recycling only 20% of garbage. Meantime, officials have no strategy for reducing compostable commercial food waste, and no regulatory framework for eliminating single-use plastics like tableware.
